WARNING re DANGERS OF FOUR WHEEL DRIVING

Four wheel driving can be dangerous. Where the applicant is a consumer as defined by any relevant law such as the Trade Practices Act 1974 or similar State laws, then certain terms and rights will be implied into a contract for the supply of goods and services for the benefit of the applicant. These terms and rights and any liability of the Nissan Patrol Club of South Australia Inc flowing from them cannot be excluded, restricted or modified by the contract. In all other cases and except where inconsistent with the above any person four wheel driving, learning to four wheel drive, undergoing four wheel drive training, riding in a vehicle being used for or in connection with four wheel drive training, or participating in any activity carried on by the Nissan Patrol Club of South Australia Inc does so entirely at his or her own risk. It is a condition of admission to membership of the Nissan Patrol Club of South Australia Inc and a condition required by any visitor participating in any activity or event of the Club, that the Nissan Patrol Club of South Australia Inc, its office-bearers, committee-persons, members and servants or agents are absolved from all liability howsoever arising from injury or damage howsoever caused (and whether fatal or otherwise) arising out of membership of the Nissan Patrol Club of South Australia Inc or participation in four wheel driving, learning to four wheel drive, undergoing four wheel drive training, riding in any vehicle being used for or in connection with four wheel driving or in any way caused by or arising out of any activity carried on by the Nissan Patrol Club of South Australia Inc whether or not such injury or damage is in any way whatsoever due to any negligent act, breach of duty, default and/or admission on the part of the Nissan Patrol Club of South Australia Inc, its office bearers, committee-persons, members and servants or agents.

Any person four wheel driving, learning to four wheel drive, undergoing four wheel drive training, riding in any vehicle being used for or in conjunction with four wheel drive training or participating in any activity carried on by the Nissan Patrol Club of South Australia Inc are only allowed to do so on the distinct understanding that they do so entirely at their own risk.

WARNING re VEHICLE INSURANCE

The Nissan Patrol Club of South Australia Inc operates under a registered constitution and a set of Club By-Laws. It is a requirement of the By-Laws that on application for membership or on renewal of membership the vehicle or vehicles declared on the membership form is or are covered by third party property or comprehensive vehicle insurance.

It is also a requirement of the By-Laws that the member must ensure that a vehicle used by the member while attending or participating in any Club event or activity, including a meeting, function or trip for the purposes of four wheel driving, learning to four wheel drive, undergoing four wheel drive training, riding in a vehicle being used for or in connection with four wheel drive training, touring, camping or attending a social event, must be covered by third party property or comprehensive vehicle insurance and show proof of such insurance if requested by a Club officer or Trip Leader.

Insurance policies vary from one Insurance Company to another. It is essential that any member or visitor attending or participating in any Club event or activity has read their vehicle insurance policy, has clarified its meaning with their Insurance Company if necessary, and understands the cover offered by that policy and in particular the cover offered when attending or participating in any Club event or activity, whether that event or activity requires the vehicle to be driven off public roads or not.

Any person, whether a member of the Club or a visitor to the Club, participating in any activity or event carried on by the Nissan Patrol Club of South Australia Inc does so entirely at their own risk and is responsible for their own insurance to cover damage to their own vehicle and damage to third party vehicles and property.

The Nissan Patrol Club of South Australia Inc, its office bearers, committee-persons, members and servants or agents are not responsible for providing insurance cover or otherwise indemnifying Club members or visitors against damage or theft of their vehicles, or damage to other vehicles or property.

It is necessary for a member or a visitor to hold a current applicable driving licence as driving without a licence or while a licence is suspended voids vehicle insurance cover.
